# Chairman testifies to U.S. House subcommittee on urgent need to invest in water infrastructure

In testimony to the U.S. House Subcommittee on Water Resources and Environment, Puyallup Tribal Council Chairman Bill Sterud expressed support for a \$2.5 billion investment in wastewater infrastructure assistance for Native American communities.

“Foundational to our Tribe are our natural resources, the fish, wildlife and fauna, water, land and air in our territory. We depend on these resources for our economic, cultural, and spiritual health and well-being,” Sterud said in written testimony that paralleled his spoken comments during the Feb. 23 hearing.

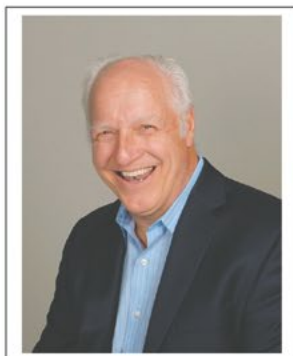

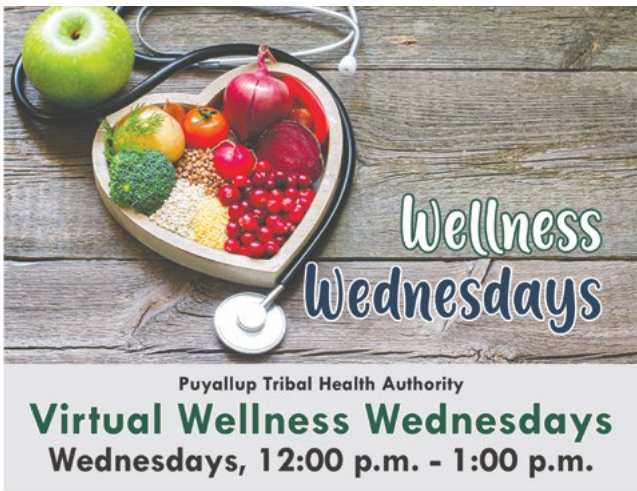

## April is Alcohol Awareness Month

- **PTHA patients and spouses** (must accompany patient & show valid ID with shared address - for first shot only).
- **Puyallup Tribal employees, spouses and households** (with employee verification and ID with shared address).

- **Puyallup Tribal-owned business employees** (with employee verification).
- **Day care employees contracted with Puyallup Tribe** (with employee verification).

Vaccines are for age 18 and up; no appointment needed. Monday - Friday, 8:30 a.m. - 4:30 p.m. Drive-through vaccines are located at the former EQC event tent parking lot, below PTHA, enter from East 32nd Street. For the second dose, please bring vaccination card.

## Take care of your children's teeth early

- A child should visit the dentist as soon as they get their first tooth, or by their first birthday.
- Start brushing teeth twice a day with fluoride toothpaste when they get their first tooth.
- Start flossing early – as soon as teeth touch!
- Caregivers should always supervise and apply the appropriate amount of



- fluoride toothpaste: Use rice size or "smear" for under age 3. Use a pea-sized amount for age 3 to 6.
- Children need help from an adult with brushing until at least the age of 8.

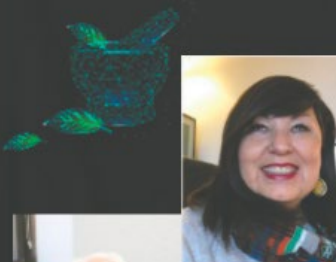

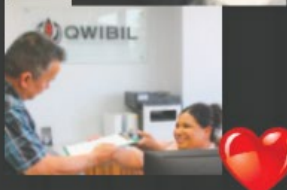

# Community celebrates **ʔay'gʷasilali, The Place of Transformation**

Two eagles watched over the March 11 ribbon-cutting ceremony of ʔay'gʷasilali, The Place of Transformation.

Tribal Council members, Culture Director Connie McCloud and witnesses spoke to how this village will not just transform the people living here, but the whole community. Each tiny home has a name, provided by the Language Program, and will soon be furnished for the incoming tenants.

“ʔay'gʷasilali. This is truly the place of transformation, but this is not just the Place of Transformation for you, our family who will live here. You are family who live here, you will also transform us and transform this place with the things you are now able to do. We look forward to learning from you. We look forward to the things you offer the community and we welcome each and every one of you home,” said David Turnipseed, Puyallup Tribal Member and ceremony witness.

All seven members of the Puyallup Tribal Council spoke at the event, expressing their gratitude for everyone who has helped with the project.

“We’re saving lives,” said Chairman Bill Sterud.

“I can’t wait to bring our members home,” said Tribal Council Member Monica Miller. “Our ancestors ... are very proud of us, I know they are.”

Each home features a Twulshootseed name that is based on a traditional teaching, and the homes’ names were read during the event. The event also included prayers, songs, dances, remarks by other witnesses and staff who have helped with the project and tours of the tiny homes.

## About ʔay'gʷasilali

The village is at 2027 E. Wright Avenue in Tacoma and is on Tribal Trust property. It was designed with critical input from the Culture, Language and Historic Preservation departments to ensure it aligns with Tribal values. The homes are arranged in a circle, and there is a community area in the center.



Each home is 8 feet by 12 feet and insulated with heat, electricity and a locking door. Case managers will work with residents to help them find permanent housing, health care, child care and other services. It is open to Tribal members in need of shelter. They must be referred by social services in the Tribe – to ask about the process, contact the Wrap Around Program at 253-382-6219 or [WrapAroundProgram@puyalluptribe-nsn.gov](mailto:WrapAroundProgram@puyalluptribe-nsn.gov).

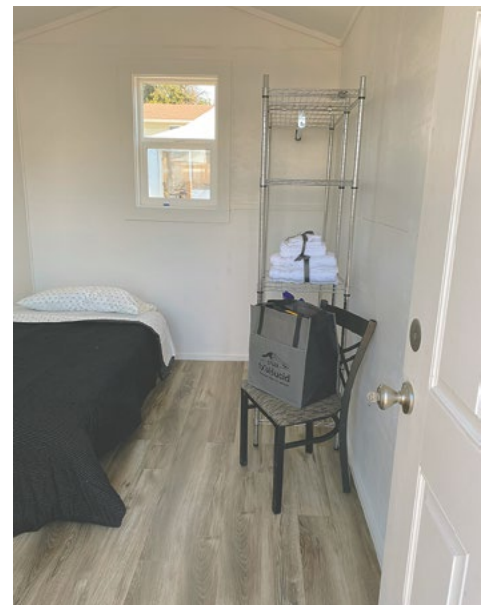

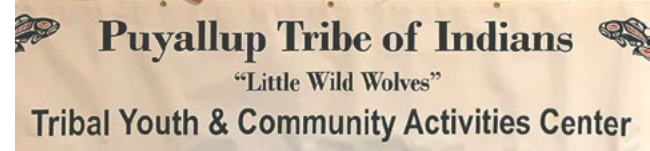
"They're starting over again, so we wanted to make sure they were taken care of," said Youth Director Lisa Earl. "They pretty much lost everything."

After the Billie-Satiacum family was able to get into a new house, the Youth Center's maintenance staff helped furnish it with items from the furniture bank, which is housed at the center.

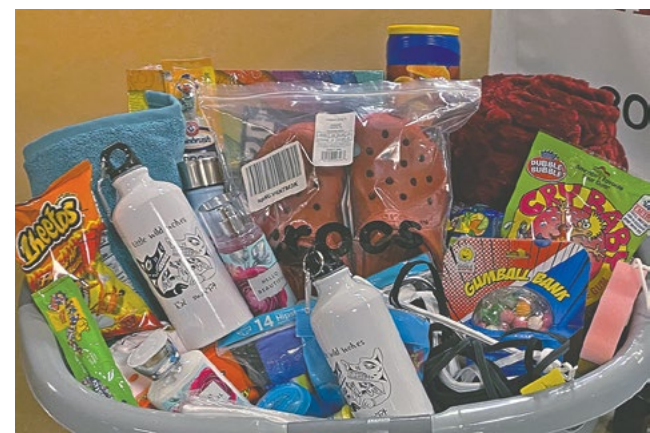

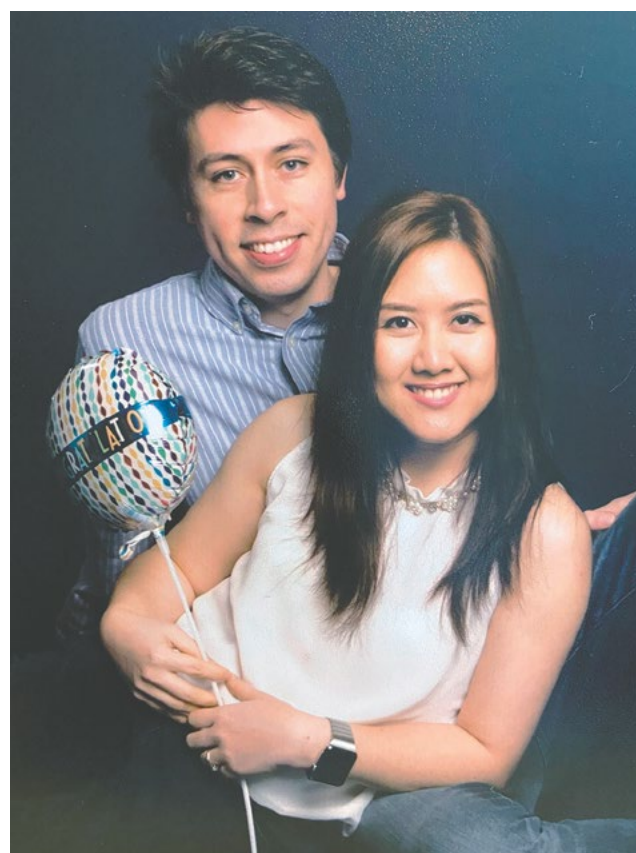

## CLS students and staff plant trees at Lake Leschi

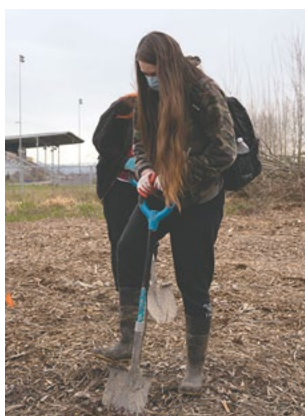

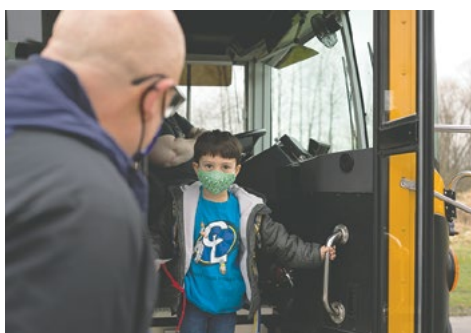

## Steps to Becoming A HERO to Children

Being a hero to a child will bring security, connection and great growth to the whole community. Below are ways that you can be a hero to a child.

- Show up!** A superhero tends to make a dramatic entrance and shows up just in the nick of time. As a hero to children, you just need to show up. The drama is not needed, but your presence is. Find ways to be there when they really need you, and often when they don't.
- Pay attention.** Children want to be seen and heard. Enjoy them when they shine and challenge them when they are testing limits. They want you to see them in all of their wonder and all their imperfection. That is how they know that you truly care about them.
- Don't be afraid of difficult conversations.** A hero can handle the discomfort. If you feel a child is on the wrong path, tell them and offer guidance to help them find the right path.
- Do the right thing.** A hero does the right thing, even when it is not easy. In fact, the right thing is seldom easy. Children are paying attention to the adults in their lives and will often model the people in their lives.

## No Hit Zone

### Children of the River Child Advocacy Center

Is introducing the "No Hit Zone" program to the Puyallup Tribal community. A "No Hit Zone" is an environment in which no adult shall hit a child, no adult shall hit another adult, no child shall hit an adult, and no child shall hit another child.

Spanking shrinks brains. Harvard Medical School found that kids who are spanked just once a month had **14-19 percent smaller brains in the decision making area.**

Spanking lowers IQ. The University of New Hampshire found that American children who are spanked at ages 2-4 have **5 less IQ points** than non-spanked children, even years later. Children spanked at ages 5-9 have **2.8 less IQ points.**

Even "everyday spanking" is consistently associated with more aggression, fighting, mental health problems, negative relationships with parents, anti-social behavior, lower self-esteem, lower cognitive ability, weaker moral values, substance abuse, delinquent behavior, and lower self-control.

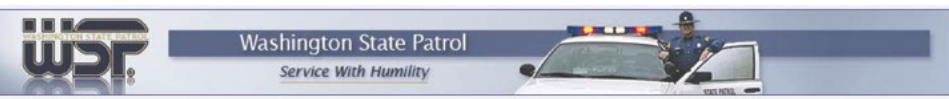

Each tiny house is 8 feet by 12 feet, is insulated, and has heat, electricity, and a locking door.

# Lushootseed name under consideration for Jason Lee Middle School in Tacoma

A name change of Tacoma Public Schools' oldest school, Jason Lee Middle School, is part of the community's efforts to honor local history and acknowledge the past.

Since last summer, many Tacoma community members have expressed concerns with Lee's past with the creation of Indian boarding schools, which caused generational trauma among many Indigenous people. Lee arrived in the area as a missionary in the 1830s and quickly started to assimilate local Indigenous people by stripping them of their customs, culture, and language as well as cutting their hair short to fit into the white culture.

A Lushootseed name is being considered for the middle school, which is situated on the ancestral lands of the Puyallup Tribe of Indians. With Twulshootseed language revitalization efforts underway, Tribal Member and employee Charlotte Basch proposed the name šəqalič Middle School, which is the Lushootseed word for "up on top."

In a statement to the school board, Basch said, "After meeting with the directors of the Tribe's Historic Preservation, Culture, and Language departments, the official recommendation from the Puyallup Tribe is to honor the rich and diverse history of the Hilltop neighborhood. Hilltop has a unique history that speaks to the diversity, and



often shared struggle, of Tacoma's residents of color. There is no better way to lift up the story of the community and its residents than by naming the school after them."

Students and staff voted on the top four proposed names, according to The News Tribune. The Tribe's recommendation of šəqalič was the second most popular option put in front of the School Board by the naming committee for consideration.

"Hilltop Heritage" received the most votes from students and staff.

"The next step in the process is for the superintendent to make a recommendation to the school board," said Dan Voelpel, Executive Director of Communications at Tacoma Public Schools. "So far she has not set a firm date for her recommendation, but it could be as early as one of the board meetings in March."

"It makes sense to enact a name change during the summer break, which is what is happening with our other school name change from Woodrow Wilson High School to Dr. Dolores Silas High School," said Voelpel.

Puyallup Tribal Member Lucia Earl-Mitchell also served on the middle school's renaming committee.

"We need to learn from our past the good and the bad, this is to ensure we don't repeat unnecessary tragedy and trauma," Earl-Mitchell said. "We should not erase history but learn from it, teach it the way we want it to be taught. Learn better, do better. We are all in this together."

## SUBMIT YOUR FEEDBACK

Puyallup Tribal community members still have time to submit their comments and offer more of an Indigenous perspective about the name change options. Jason Lee Middle School interim principal Michael Knuckles, is collecting comments, as is the school board.

# Estuary and new elementary school named in honor of Puyallup Tribe

Gig Harbor City Council and the Peninsula School Board recently approved names that honor the Puyallup Tribe.

On Feb. 25, the School Board voted to name its new school Swift Water Elementary School. It is at 10811 Harbor Hill Drive in Gig Harbor.

"The name Swift Water is taken from the translation of the Gig Harbor's original Native American inhabitants (sə'əbabš) and their connection to the swift currents of the Narrows Passage," the school district



posted in a news release. "The Swift Water band of the Puyallup Tribe gifted a native building recognizing that the settlers needed one to teach their children."

On Feb. 22, the Gig Harbor City Council voted 6-1 to rename Austin Estuary to tx'aaalqəl Estuary. The 7-acre estuary is in the North Creek Watershed and includes the area around Austin Park and Donkey Creek Park.



"It's restoring the original village site name, which has never been done in Gig Harbor," said Puyallup Tribal Member and Land Use Planner Jennifer Keating.

The resolution, in part, reads: "Whereas, the City recognizes and honors the fact that Gig Harbor is built upon the homelands

and villages of Indigenous Peoples of this region better known as a band of the Puyallup Tribe called sǎwəbabš (translated: “swift water people”); and whereas, the land surrounding the estuary of North Creek was the location of along house of the sǎwəbabš band and the area was of vital importance to the sǎwəbabš band for salmon fishing, clam and oyster cultivation, and canoe carving.”

The City Council agreed to use Twulshootseed for the signage, and not use a phonetic spelling or translation for the new name. In English, it means “place where game exists.”

Tribal Council, Historic Preservation, Language Program and Land Use and Planning Department all had members who served on the city’s ad hoc advisory group who proposed the reclaimed name. Bean and Keating were involved due to their roles at work, but they are also Gig Harbor residents.

“I was moved beyond words,” Keating said. “This is something that has been so desperately needed in the Gig Harbor community for so incredibly long. There’s been this old thought that when you teach tribal history out there, you’re replacing Scandinavian history and that’s simply not reality. ... Native history is Washington state history. We can no longer look at it as an option to teach that history – it is history.”

Bean said she raises her hands to Keating for her leadership and work on the Gig Harbor efforts.

“She also serves as a Native American Parent Representative for the Peninsula School District,” Bean said. “It’s important to note she did work in Historic Preservation under Judy Wright. The combination of education of the land and history of our people becomes extremely valuable and impactful.”

Last fall, Gig Harbor City Council adopted a resolution to recognize Indigenous Peoples’ Day in October, recognize Native

American Heritage Month in November and fly the Puyallup Tribe’s flag at City Hall. Future plans include recognition of the Gig Harbor waterfront as a historic district for the tribe, Keating said.

“Learning our history in Gig Harbor has been mind blowing,” Bean said. “The band of sǎwəbabš are the direct ancestors of the Squally/Tougaw families. My partner Kirby Manzaneres Jr. is a direct descendant of the sǎwəbabš which through historical (records) we found to have lived off of Wollochet. The part that blows my mind is that his parents and siblings all live off of Wollochet now. I fought moving out to Gig Harbor. To know our children were called to be here is chilling, necessary and beautiful.”

She added that the Tribe is advocating for cultural and historical value to each area within its boundaries and ancestral lands.

“This is a beautiful time of restoration, revitalization, reclaiming and educating,” Bean said.

The Court entered a Temporary Protection Order on January 29, 2021 and set the Protection Order Hearing for February 24, 2021 at 10:00 AM. Personal service upon Respondent failed. ## Hunting tags required by March 31

It's time to return your hunting tags for a \$15 rebate.

To be eligible for a \$15 refund, you must return your **completed** hunting tag(s) in the Hunting Tag Drop Box no later than March 31, 2021. Be sure to include GMU where you hunted, kill date, sex of animal, pregnancy status or how many points for bulls/bucks.



Even if you didn't get out and hunt or you didn't kill anything, your information is important to the Tribe in managing wildlife resources. The information you provide is used to develop future hunting seasons and regulations for the Tribe by the Tribal Hunting and Wildlife Department.

Hunters who do not turn in their completed tags by the March 31 deadline will be subject to fees and penalties up to \$200. The \$15 hunting tag rebate checks will be processed after the March 31 tag return deadline.

Responsible for the enforcement of all tribal laws and regulations which shall include both land and marine areas which are under tribal jurisdiction. The police officer should possess understanding of sovereignty, tribal regulations and the need for their enforcement.

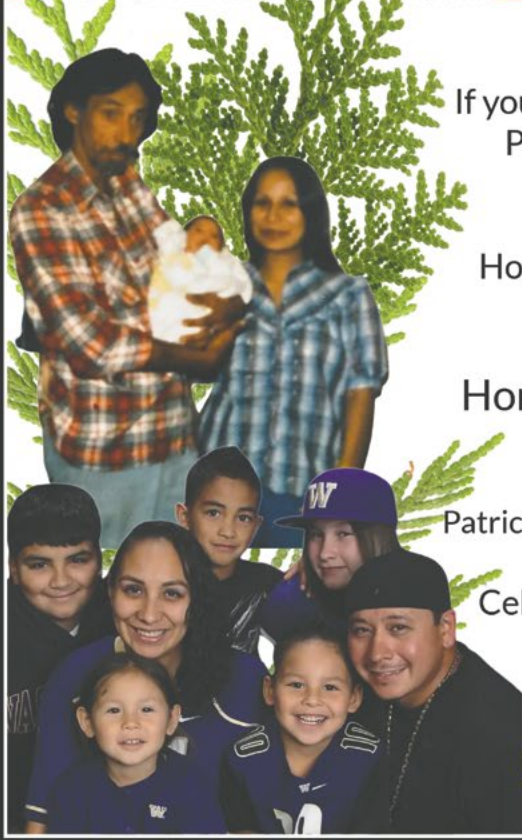

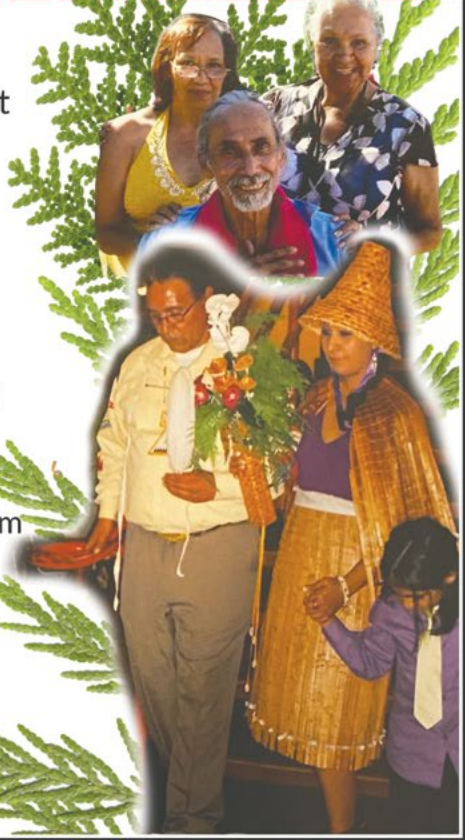

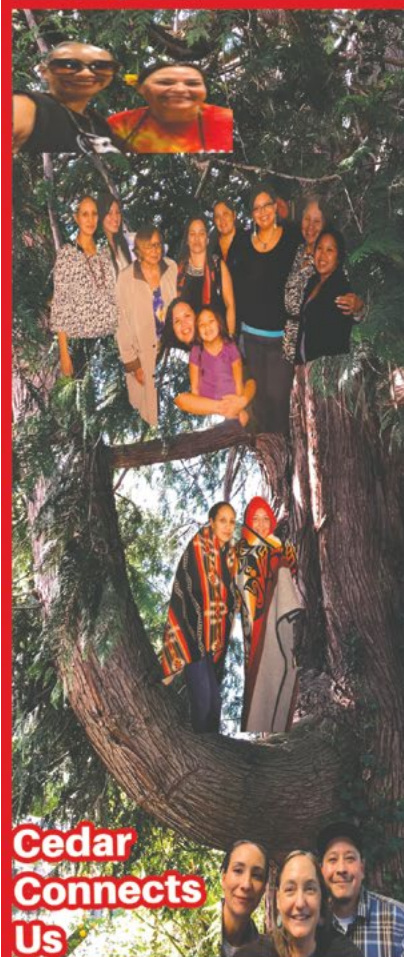

Because I had an opportunity to get one this month and start protecting the community I live in, and the Tribal community that I work in.

My name is Lynette Bedford and I work in the Elders department.

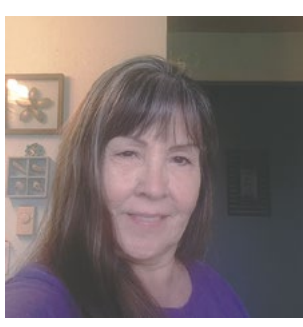
I got the vaccine first off to protect my Elders. I work closely with the Elders on a daily basis. I feel it is my duty to serve and protect them, and I could do that by getting the vaccine.

Second, I got it to protect the ones I love. COVID hit my sister's household. Out of nine people, seven got COVID. My strongest sister ended up in the hospital on a bi-pap machine. She almost lost her life (we call her Wonder Woman). My other sister who has Down Syndrome is a high risk only had a runny nose.

You don't know if you are asymptomatic and spreading it. It can kill the unexpected and leave them weaker than ever before.

So last I got it to protect my community because if I can stop the spread with me, why not protect the ones we care about and love.
