Dear Chairman Dillon:

The U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) has approved the *Puyallup Tribe of Indians All Hazard Mitigation Plan* as a Tribal Mitigation Plan, in accordance with 44 CFR Part 201. The Puyallup Tribe of Indians is now eligible to apply directly to FEMA as a grantee for Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act) non-emergency programs through April 30, 2017. To continue eligibility, the plan must be reviewed, revised as appropriate and re-submitted for approval within five years from the date of this letter.

As a result of the Disaster Mitigation Act of 2000, States and Tribes are required to develop and maintain hazard mitigation plans compliant with FEMA standards as a condition for receiving non-emergency Stafford Act assistance. Applicable Stafford Act assistance includes Public Assistance (Categories C-G), Fire Management Assistance, Hazard Mitigation Grant Program (HMGP), and Pre-Disaster Mitigation grants.

FEMA's approval of your plan as a Tribal Mitigation Plan provides the Puyallup Tribe of Indians eligibility to apply for various Stafford Act programs. All requests for assistance, however, will be evaluated individually according to the specific eligibility and other requirements of the particular programs. For example, a mitigation action identified in the approved plan may or may not meet the eligibility requirements for HMGP funding.
