WHEREAS, the Puyallup Tribe has existed since creation as the aboriginal people, who are the owners and guardians of their land and waters; and

WHEREAS, the Puyallup Tribe is an independent sovereign nation having historically negotiated with several foreign nations including the *United States* in the *Medicine Creek Treaty*; and

WHEREAS, the Puyallup Tribal Council is the governing body of the Puyallup Tribe of the Puyallup Reservation in accordance with the authority of the sovereign rights as the aboriginal owners and guardians of their land and waters as reaffirmed in the *Medicine Creek Treaty*, and the *Constitution and By-Laws* as amended and approved by the Tribe and Assistant Secretary of the Interior; and

RESOLUTION SUMMARY:

EXECUTION OF A TRIBAL RESOLUTION TO RECOGNIZE MAY 2019 AS MILITARY APPRECIATION MONTH. PLEASE REVIEW ENTIRE TEXT.

WHEREAS, the *Tribal Council of the Puyallup Tribe of Indians* recognizes and honors service to others; and

WHEREAS, the *Tribal Council of the Puyallup Tribe of Indians* recognizes that military veterans have by their service answered a high calling in service to others; and

WHEREAS, the U.S. Department of Veterans Affairs has stated that American Indians serve at a high rate in the military as compared to people of other ethnicities; and

WHEREAS, the month of May is recognized in the United States as National Military Appreciation Month; and

WHEREAS, May 18, 2019, is Armed Forces Day; and

WHEREAS, May 27, 2019, is Memorial Day,

BE IT RESOLVED, by the *Tribal Council of the Puyallup Tribe of Indians* that May 2019 be recognized as Military Appreciation Month; and

BE IT FINALLY RESOLVED, by the *Tribal Council of the Puyallup Tribe of Indians* that all Members and employees of the Puyallup Tribe of Indians who are actively members of the military or veterans be recognized for their service.
