- Set up compliant work zones for maintenance and operations crews
Serve as a Washington state certified flagger safely guiding and directing traffic through work zones
Provide manual labor for maintenance, landscaping, and vegetation control projects
- Provide manual labor and data tracking for asset assessment crews
- Interact well with the public and provide excellent customer service
- Maintain and safely operate small power tools and landscape equipment
- Work is performed outside sometimes under adverse weather conditions

QUALIFICATIONS:

- 6 months to 1 or more years of experience performing skilled or semi-skilled labor such as traffic control/operations, road maintenance, or landscaping, construction, or other closely related work.
- Possession of valid Washington State Driver's License and a safe driving record is required
- Ability to work a variety of shifts, including nights, holidays, and / or weekends
- Ability to report to various work locations throughout Pierce County
- Ability to perform strenuous physical labor, including lifting up to 50 pounds
- Ability to kneel, bend, climb, reach, crawl, work at heights, and walk on uneven terrain
- Ability to work around various types of vegetation that emit dust, pollen, scents/odors, as well house a variety of insect types.
- Ability to work around fertilizers and landscaping chemicals
- Ability to work in all types of weather conditions
